

# REMEMBERING WHO WE ARE

By Mike Bradley - LCMC - January 21, 2025 Printed with permission. Emotional, relational, and spiritual health, and long-term sustainability. This is my hope and prayer for our association as I move toward retirement from my position as LCMC's service coordinator. That may not seem to be something that needs to be stated, but just look around. Long-term health and sustainability for associations and denominations cannot be assumed, nor taken for granted. How many once healthy and mission-minded associations have found themselves in now unhealthy and unsustainable positions?

In the years ahead, three keys for LCMC's health and long-term sustainability will be: 1) remembering who we are, 2) remembering what we're called to, and 3) remembering where we're going. My focus in this article is on remembering who we are.

First, we must remember that we are a team. We are not a team of teams, but one team, a kingdom of God team! It's been said that LCMC is a big tent that welcomes different expressions or nuances of what it means to be Lutheran, and this is true. However, like any great team, we acknowledge and incorporate the different strengths and gifts that each player (or groups of players) bring to the team. A good team is a coming together of different strengths, gifts, and points of view to accomplish a common mission. And a good team can always accomplish more than any gifted individual. A key to LCMC's health and long-term sustainability will be honoring, encouraging, and learning from one another, and functioning as one team: a kingdom of God team.

Remembering who we are will also mean remembering our name and what it says about us. We are LUTHERAN Congregations in Mission for Christ. It is important that we remember this and not only safeguard our Lutheran theological distinctives, but seek to intentionally teach and proclaim them in such a way that they are understood and embraced by members and leaders in our congregations. Our Lutheran theological distinctives are not some dusty old dogma, but rather, are essential keys for effective ministry and mission in the world today.

We are Lutheran CONGREGATIONS in Mission for Christ. We are an association of congregations. The impetus, authority, and responsibility for ministry and mission lies with the congregations of LCMC, not with a hierarchical office at a national level. As our mission statement declares, we exist to connect and encourage Lutheran congregations in the mission of the Gospel and to develop healthy leaders for that mission. Let us continue to be intentional in living out this essential aspect of who we are in the years ahead. We are Lutheran Congregations IN MISSION for Christ. We are an association of congregations that says we are committed to the Great

Commission in the spirit of the Great Commandment. However, if we are not careful, we, like other associations and denominations before us, will fall prey to settling for this being an aspirational, rather than an actual value. Let us continue to encourage one another in living out the mission that God has given us in all the creative and diverse ways represented by our congregations, districts, and fellowships.

We are Lutheran Congregations in Mission FOR CHRIST. It's all about Jesus! It's all about God and His glory, not ours. Together, as a team, we serve the Risen Saviour and His purposes and His agenda in the world today.

Remembering who we are will be essential if we are to experience God's ongoing work of increasing our capacity for health and maturity as individuals and congregations. And it will be an essential key to a long-term sustainability.

- · Ministry Programs, Structure and Future Some portions of the MSP will be completed jointly by both congregations and may require input from joint councils.
- Pastor Job Description including emphasis in secretary will be chosen. leading / focusing on which areas of ministry.

- · Candidates desired personal characteristics.
- Candidate's minimum qualifications.
- · Candidate's knowledge, skills and abilities.
- · How will the congregation provide support (vacation time, continuing education, sabbatical, staff support, etc)

After the MSP is completed, it will be reviewed by the councils and congregations for input, adjusted as needed and then a Call Committee will be called.

### SPECIAL CONGREGATONAL MEETING

# Notice of Special Congregational Meeting - February 16.

A Special Congregational Meeting will be held immediately following worship on February 16. The purpose of this meeting is to pause and review the Council Restructure Task Force, initiated on January 26.

During the Annual Meeting on January 26, a motion was made, approved, and passed with a two-thirds majority vote to establish a task force to restructure the council format.

Following the meeting, a congregation member raised concerns to Council Chair Rudy Nieman regarding a constitutional violation in forming the task force. As a result, the council convened a Closed-Door Special Meeting on January 28 to review the matter and confirmed that the formation process did not align with constitutional requirements. Given the importance of this initiative, the task force will be temporarily paused while its structure and timeline are revised to ensure compliance. Per our Constitution, at least 11 active members

are required to form a Council Restructure Task Force. If you are interested in serving on this task force, please contact the church office at <a href="mailto:silcom">silcom</a> or Council Chair Rudy Nieman at <a href="mailto:silcom">silcom</a> interested in serving on this task force and approve participants at the February 11 Council Meeting so that the task force can commence promptly.

A designated council member will be available to provide guidance, answer questions, and supply relevant materials, including past council outlines, LCMC council examples, and our Constitution. Once the task force completes its proposal, it will be submitted to the council for review, with a maximum review period of 60 days. The council does not intend to delay this process unnecessarily.

Following council review, the proposal will be shared with the congregation, allowing a 30-day review period. A Special Congregational Meeting will then be scheduled for a vote on the proposed council restructuring.

Your participation and engagement in this process are greatly valued.

invited to a special VIP brunch hosted by the students to recognize each member's contribution. Club 52 donation forms are on the bulletin board if you would like to contribute.



**Via de Cristo Retreat** Via de Cristo (VDC) is a Spanish phrase meaning "Way of Christ." VDC is a highly structured three day weekend designed to strengthen and renew the faith of Christian people and bring them to a new awareness of living in God's grace. It's three days in length, beginning on Thursday, March 6 and ending on Sunday, March 9. The participants live, study, worship and commune together daily. Fourteen talks are given, nine by lay people and five by clergy. Following each talk, small round table discussions focus on the main points of the talk and a poster is done. The talks, in an overlapping fashion, present the Christian life, based on the person and teachings of Jesus Christ. There is music and singing, food and fellowship, a time for laughter and for prayer. This spring, VDC is held at Forest Springs, Westboro. 
